AFFIDAVIT

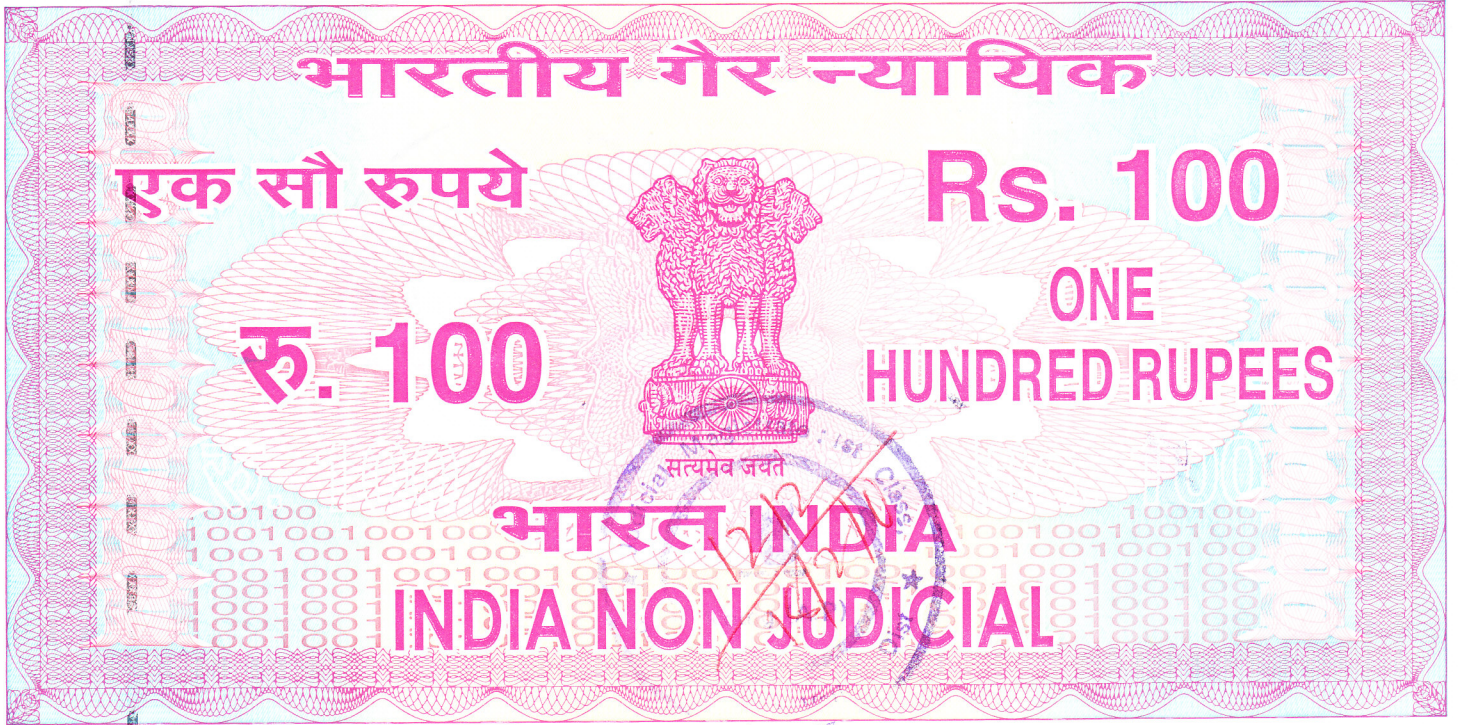




