## NOTIFICATION

In pursuance of the recommendation of the State Level Fee Review Committee of B. Ed Course for Private Higher Education Institutions, the Governor of Arunachal Pradesh is pleased to notify the rate of fee for pursuing B. Ed Course at **Rs. 90,000/- (Rupees ninety thousand)** only per annum w. e. f the academic session 2024-25. The rate as fixed shall stand uniform for all the Private B. Ed Colleges and Private Universities functioning in the State and it is also mandatory for the concerned institution to maintain uniform fee structure

The Private Colleges and Universities are further directed to maintain the terms and conditions of the UGC/ NCTE in the appointment of the teachers and their service conditions as laid by the Regulatory Bodies.

Non compliance of this notification by the Private Colleges / Universities shall be dealt under the section 17(1) (2) & (3) of the Arunachal Pradesh Colleges and Other Institutions of Higher Education (Establishment and Regulations) Act, 2010 and also treated as violation of Hon'ble Supreme Court's directives

A student has to deposit the admission fees in two phases as shown in the table above. The payment for the first phase will be for **1<sup>st</sup> and 2<sup>nd</sup> Semesters** i.e **Rs. 80,000/-** (Eighty Thousand only) at the time of admission in the month **July 2025** and **Rs. 50,000/-** (Fifty Thousand Only) at the time of re-admission for the second semester in the month of **January 2026**.

The payment for the second phase will be for **3<sup>rd</sup> and 4<sup>th</sup> Semesters** i.e **Rs. 30,000/- (Thirty Thousand only)** at the time of admission in the second year in the month of **July 2026** and **Rs. 20,000/-** (Twenty Thousand only) at the time of re-admission for the **4<sup>th</sup> Semester** in the month of **January 2027**.
